Guiding Patients to Better Understanding Jefferson Healthcare's Revised Prices for Improved Transparency

Getting an X-ray, a CT scan or a blood draw at Jefferson Healthcare will cost patients less in 2019 following an internal pricing review conducted in Fall 2018.

These common types of services, which include those offered under the umbrella of diagnostic imaging (X-ray, ultrasound, CT scan and MRI), laboratory tests or respiratory therapy, all have lower associated prices after system-

wide adjustment in Jefferson Healthcare's pricing structure.

"The drop in pricing for these services is extremely important for most households," said Hilary Whittington, chief financial and administrative officer at Jefferson Healthcare. "It translates into real cost savings for them."

The revised pricing, which took effect Jan. 1, was developed after all prices were studied by a hospital review team, an annual practice.

for television studios to working at an architectural firm as well as on high-rises for Baugh Construction (now Skanska Construction) for a decade. He spent the last several years as a project manager and foreman with various custom home firms in Washington, Florida and North Carolina, before relocating to Jefferson County a few months ago.

Now focused on remodeling and tenant improvements for residential and commercial buildings, Mittet's recent projects include complete kitchen and bathroom remodels and building a 2,000-square-foot deck. With woodworking, tile installation, carpentry, residing, and paint and stain among his range of services, he can also match existing styles from colonial to modern.

With a service area stretching

across Eastern Jefferson County, Mittet is a largely one-man operation who likes to take on a single job at a time. With attention to detail – big or small – being of utmost importance, he ranks honesty, punctuality, jobsite cleanliness and customer satisfaction among his top priorities.

"I like to build a project on paper first, and the scope of work and what the customer expects being in the contract is really important," Mittet said. "For me, it's about customer satisfaction – that their expectations are met with what they envisioned."

To that end, Mittet said he likes for customers to be involved with project details and decisions because it offers a sense of empowerment and control.

In addition to pre-construction consulting as well as design work, Mittet is also available as an owner's representative whereby he serves on a homeowner's behalf in overseeing that other contracted projects are completed in accord

with the contract.

"Everything being on the up-and-up is very important to me," Mittet said of his work philosophy. "If you need a permit, you need a permit."

Launching the adjusted prices coincides with a new requirement by the national Centers for Medicare and Medicaid Services (CMS) which also took effect Jan. 1. The rule requires all hospitals to post prices online and update them annually.

Jefferson Healthcare's analysis of pricing and eventually their adjustment was accomplished to ensure that prices are fair, competitive and comparable to other hospitals in the region, and reflective of the resources needed to provide each service. Resources include staffing, time, equipment and materials used for service. Every line of the list of prices and corresponding procedure codes (called the Chargemaster) was reviewed.

Given their proximity, Jefferson Healthcare looked at Olympic Medical Center in Port Angeles and Harrison Medical Center in Bremerton. Also in

the mix for comparison were Seattle area hospitals Harborview Medical Center, Overlake Hospital Medical Center, Providence Regional Medical Center Everett, Swedish First Hill Medical Center, University of Washington Medical Center, and Virginia Mason Medical Center; and St. Joseph Medical Center and Tacoma General Hospital in Tacoma.

As the result of the review, some prices increased, although many more were adjusted down.

Whittington said patients will pay more for trips to the emergency department, for example, but that the price change is to keep Jefferson Healthcare in line with prices at other emergency departments. Also, visits to the emergency room are often associated with diagnostic tests such as lab work or an MRI – which will cost less, sometime as much as 10-25 percent less.

Ultimately, the net effect is

a 2.1 percent increase across thousands of price codes. Typically, hospitals increase their prices 3-6 percent per year.

"We're pleased to have tackled this recalibration with an overall increase lower than the market trend," Whittington said.

As a public hospital with lower tax support compared to other public hospital districts, the goal was to set prices at a sustainable level to ensure that vital services to the community are maintained.

"Providing care for our community is the reason we are here," Whittington said. "That being said, we understand people have a choice for their care."

She said the hospital doesn't want cost to be a barrier to people deciding on Jefferson Healthcare for their health needs. "We want to be their choice."

Jefferson Healthcare's revised prices are now posted on the Jefferson Healthcare website,

jeffersonhealthcare.org. Patients may learn about the prices by finding the link "Jefferson Healthcare Pricing Chart" under the frequently asked questions in the "Pay My Bill" tab.

The list can be a useful tool to understand prices, although most services involve a combination of prices. Whittington indicated it is important to realize that in many cases it might be impossible to predict final charges because of variables that affect services. Patient obligation varies by payer and can include copays, coinsurance, or other types of patient responsibility. Insurance companies determine the

portion of the bill for which the member is responsible.

Posting all prices is part of a nationwide effort to improve transparency. Knowing service prices might assist some patients, but the reality is that this much raw information might be confusing to many users, Whittington said.

Wildflower Landscaping LLC

Despite being a second-generation family business founded over 30 years ago, Wildflower Landscaping LLC, under the leadership of owner Jess Norton, is still finding ways to raise the bar and expand the scope of landscaping. A drive through Port Ludlow reveals many landscapes installed by Jess and his mother, Wildflower's founder Ann Norton, dating back to the 1980s. Wildflower still maintains several of them, despite the properties having sold again and again.

From maintenance to irrigation to new construction, Wildflower brings together traditional landscape design and materials with innovative custom-fabricated solutions like Corten steel edging, cut and welded on-site to hug just the right curves or engineered stone patios designed to tuck perfectly into the topography, connecting the yard and the home and bringing the inside outside. Operations Manager

Christina Tinling sums it up, "Nothing is too big or too little. We pull weeds by hand, and we break ground with heavy equipment so you can begin work on the homestead of your dreams."

These more ambitious installations require a broader team of experts, so Jess saw the opportunity to grow by bringing in subcontractors. Their contracting efforts extend all through our community, involving arborists, electricians, carpenters, and other landscapers. Even though Wildflower is now a fully licensed and bonded general contractor, their efforts are still confined to the needs outside the walls like decks and patios. As Jess likes to quip, "I'm not housebroken. I only work outdoors."

Even while directing construction of impressive spaces, Wildflower stays true to their roots. Jess and Christina still hand select the perfect specimens for their clients' taste,

often traveling hours to just the right nursery to find them, and their team of local talent still put in the time and effort to keep "saving the world, one landscape at a time."

Began as JCCC Volunteer: 2019


Frank W. Garred is a retired Washington state newspaper publisher/editor/reporter, owning and operating community newspapers on the Olympic Peninsula between 1967 and 2002. He joined the Chamber as a volunteer in January.

Garred served as board member, officer and president of the Port Townsend Chamber of Commerce in the early '70s.

After earning a Journalism Degree at the University of Washington in 1958, Garred served in the Army as an infantry officer in Korea and at stateside posts prior to joining the news staff of the *Aberdeen Daily World* in December 1960. He was a reporter and editor from 1960 until 1967 with daily and non-daily newspapers before purchasing the *Port Townsend Leader* newspaper in 1967 from the Richard McCurdy family here.

In Port Townsend, Garred co-chaired the Rhododendron Festival Committee two years with Uptown barber Fred Lester, served as interim coordinator for the United Way fund drive one year, was a founding member of the Rhody Run Committee, serving on its successor Port Townsend Marathon Association board several years, and as race-announcer in more recent years, "retiring" in 2016.

Along the way Garred's professional career extended beyond Port



Townsend to include service with state, national and international Journalism organizations, education institutions, and statewide advocacy groups related to government transparency: access to open public records and meetings.

Frank and wife Patricia – a collaborative union of 60 years – continue life in Port Townsend, still "newcomers." However, son Chris and daughter Susan, respectively in Dallas, TX, and Seattle with their families and pursuing professional careers, successfully completed their 12-year education obligations in the Port Townsend School District, becoming "almost old-timers."
