the event.



morphed and grown during that time until now, when that project is coming to fruition.

The park will create a gorgeous entrance to our community, inviting all those who enter to rest a moment, experience the displayed sculpture, and maybe step into the Visitor information Center to plan their adventures with our intrepid volunteer team. Lean Thinking is Improving Life in Jefferson County

Several organizations in Jefferson County have combined to improve our life by building a Lean infrastructure. Is it working? And what are the next steps?

Over the past six years, EDC Team Jefferson, the Jefferson County Chamber of Commerce, and Jefferson County Foundation have provided the wherewithal to introduce Lean Thinking to 80 organizations and over 700 individuals through a combination of workshops, classes, and on-site presentations.

Perhaps the easiest to understand is the impact on our local businesses. **Organizations such as Mt. Townsend Creamery, the Food Co-op and others have seen profits and sales increase from 30-100% while being constrained to their existing footprint and workforce.** Mt. Townsend Creamery has used Lean Thinking to get a better handle on inventory, while reducing last-minute scrambling for parts and materials. The Food Co-op has engaged everyone to identify and reduce wasted effort as well as improve inventory control.

Another business, **Finnriver Cidery, uses Lean Thinking to operate more**

effectively and increase efficiency in production – both in rethinking old systems as well as in implementing new systems and equipment. They have created an environment where employees can focus on improvement in a positive and constructive way.

Agencies such as our public libraries and the Northwest Maritime Center's Chandlery can demonstrate how Lean Thinking can improve life for many in Jefferson County. At the Jefferson County Library, the process for getting new materials onto the shelf once it's received by the library, has decreased from 2-3 weeks down to 2-3 days. Similarly, many types of repairs have seen a similar decrease in time to get damaged material back into circulation.

At the Port Townsend Public Library, a process of color-coding shelving carts also gets materials back on the shelves sooner. These improvements have also reduced stress and effort on the part of library staff. The staff of the Chandlery applied Lean Thinking to their stockroom. The changes that they made and are sustaining have reduced the time customers need to wait for items, reduced staff frustration, and initiated

a stronger continuous improvement methodology.

And this is the tip of the iceberg regarding the impact that Lean Thinking has had in Jefferson County. **Organizations as diverse as manufacturing, agriculture, retail, healthcare, education, construction, non-profit, government, and technology have been part of our county's Lean journey and continue to move forward.** We are building improved training for individuals and smaller companies and continue to add sectors to our Lean community.

What is Lean Thinking?

Lean Thinking is an improvement methodology focusing on providing customer value and increasing process flow.

RISING ENTREPRENEUR

Our local companies never cease to amaze us with their innovation and the broad reach of their products and services – regionally, nationally and internationally. Each month, we will highlight a local business that is an innovative and rising sector leader whose entrepreneurship is expanding and adding to the local economy and strengthening our workforce.

GBF Catering (“God Bless Food”)

Thysen Scott’s passion is food. Although his career started in flooring at the age of 15, learning how to sell and install flooring through his mother’s carpet store, his love has always been cooking food. As the second oldest of eight kids, he learned to cook at the age of 8, often preparing the meals for the family. This wasn’t his only exposure to cooking food.

Thysen, who with business partner and wife Debi are proprietors of Port Ludlow-based GBF Catering, comes from a family of restaurateurs. His mother’s side owns the Taco Time franchise. His father owns seven restaurants in the Seattle area (where Thysen cooked and managed for two years in his mid-20s), and his aunt owns one of the largest catering companies in the Seattle area (where he cooked for Microsoft and other groups of up to 1,200 people).

From Flooring to Food

Thysen’s flooring business brought him to Jefferson County in 2007, so he could be closer to his full-time contract installing for Westport Yachts in Port Angeles, Westport and Hoquiam. Then in 2009, Thysen met his soon-to-be bride Debi and they married in 2010.

For anyone who knows Thysen well, they know he cooks for everyone he can, as often as possible, delivering food to friends, customers, and those he feels “need a good meal, free of charge.”

Although the exposure to food has always been there, and his love for cooking has always been his passion, it wasn’t until the fall of 2013 when he was encouraged to start catering after doing a flooring job for the Port Townsend Paper Corporation through his primary business, “The Carpet Specialist.” After

bringing in his specialty food to Rita Hubbard and the staff, they asked Thysen if he would cater their Christmas party. That’s where it all “officially” started.

In December 2013, Thysen and Debi started their company, GBF Catering, which stands for “God Bless Food”... and Thysen explains, as he points up with his finger, “all the Glory goes to Him.”

One Great Meal at a Time

GBF caters for events of all sizes and types, including corporate events, non-profit, birthdays and anniversaries, celebrations of life, etc. They pride themselves on serving hot food hot, cold food cold, and making everything taste great.

Thysen jokes, “I want to feed the world, one great meal at a time,” and he offers American favorites

that are taken up a few notches to bring out the best in everything he serves. Catering is the first step in food for Thysen, and there are always plans in motion for the future...which definitely revolves around food.

While Thysen and Debi run the catering business, they also have a solid core of staff to help with service at larger events. Susan Lind, a family member, has been helping since the very first event. “We are blessed to have such a great team of people willing to jump in and help sporadically when needed,” said Thysen.

Community Catering

GBF Catering has also become a food favorite at several community events, including Port Ludlow Movie Night. Their next event that is open to the public will be the Hadlock Building Supply Customer Appreciation Lunch

on May 4, where they will provide a Free All You Can Eat Taco Bar from 11 a.m.-2 p.m.

In addition to collecting glowing testimonials from satisfied clients, this growing company has also been collecting community accolades. Thysen and Debi were recently nominated for a Jefferson County Community Leadership Award in the Young Professionals category, and Thysen has won the Best Chef category in *The Port Townsend Leader* Reader Poll for two out of the last three years (coming in 2nd place last year), as well as Best Flooring. It appears that he has found his home.
